RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely, ANANDGRAM KRUSHI VIKAS MANDAL'S GIRWALI, TQ. BHOOM, DIST. OSMANABAD, PINCODE-413526 MAHARASHTRA (WRC/APW05202/123642) under section 14 of NCTE Act. 1993 for conducting B.ED. course vide order dated 18.03.2008 for an annual intake of 100 students.

AND WHEREAS, the letter for submission of Affidavit regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution submitted affidavit vide letter date 13.01.2015.

AND, WHEREAS, Revised recognition order was issued for two basic units (50 student each) to the institution on 31.05.2015.

AND WHEREAS, the Show Cause Notice was issued to the institution on 24.11.2016. The institution has not replied so far.

AND WHEREAS, the matter was placed in 285th Meeting of WRC held on June 19-21, 2017 and the Committee decided that "The case file was seen. Show Cause Notice was issued to the institution on 24.11.2016. The institution has not replied so far.

Therefore, Recognition is withdrawn from the academic session 2018-2019."

AND WHEREAS, the Withdrawal Order issued on 01.01.2018. The institution filed an appeal to the appellate authority.

AND WHEREAS, the appeal order dated 24.07.2018, "The committee concluded that the matter deserved to be remanded to the W.R.C with a direction to consider these documents to be submitted to them by the appellant and take further action as per the NCTE Regulation, 2014. The appellant is directed to forward to the W.R.C all relevant documents with reference to the SCN. Including the approval letter of the university within 15 days of receipt of the orders on the appeal."

NOW THEREFORE, the council hereby remands back the case of Anandgram Drushi Vikas Mandal, Girwali, Bhoom, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was placed in 295th Meeting held on July 30-31, 2018 of WRC and the Committee decided that *"...The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 24.07.2018 has remanded the case to WRC for further processing the application.*

The WRC examined the file and found that staff profile submitted does not have date of appointment of staff which is mentioned in university letter dt. 23.05.2018 submitted by the institution. However, the staff profile consists of only one principal and 12 faculty members which is sufficient for one unit. If the institute desire two units it should submit an approved staff profile of 1+15 failing which the number of units will be reduced to one.

Hence, Compliance should be submitted by the institution within one month."

AND WHEREAS, the of clarification letter issued on 07.08.2018 and reply submitted by the institution on 07.08.2018 & 21.08.2018.

AND WHEREAS, the matter was placed in 296th Meeting of WRC held on August 28-29, 2018 and the Committee decided that *"...The case file was seen. In the 295th meeting, the institution was asked to submit compliance regarding staff. The staff profile does not have the date of appointment. However, the WRC considered the letter dated 23.05.2018 from the University regarding the appointment of staff.*

As per notification dated 09.06.2017, all faculty members are required to have NET qualification. Principal is also not qualified. Hence, the Withdrawal Order dated 01.01.2018 stands"

AND WHEREAS, the Withdrawal Order issued on 10.09.2018. The institution filed a appeal to the appellate authority.

AND WHEREAS, the appeal order dated 31.12.2018 *"The committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the appellant's letter dt. 02.09.2018 and the request contained therein and take further action as per the NCTE Regulations, 2014. The committee after perusal of the memorandum of appeal, affidavit documents available on records and considering the oral arguments advanced during the hearing the committee concluded that the appeal deserves to be remanded to the WRC with a direction to consider the appellant's letter dt. 02.09.2018 and the request contained therein and take further action as per the NCTE Regulations, 2014.*

NOW THEREFORE, the Council hereby remands back the case of Anandgram Krushi Vikas Mandal's late Maharudra (Pappa) Mote College of Education (B.Ed), Girwali, Bhoom, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was placed in 306th Meeting of WRC held on April 29-30, 2019 and the Committee decided that *"The original file of the Institution along with appeal order 31/12/2018*



and other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:

The institution has submitted reply vide letter dated 2/9/2018, 08/01/2019 & 09/04/2019

On perusal of the reply of the institution and appeal order dated 31/12/2018 the committee decided to restore the recognition for B.Ed. programme of two years duration for one unit 50 students) and to issue a formal recognition order accordingly.

NOW THEREFORE, the recognition of ANANDGRAM KRUSHI VIKAS MANDAL'S GIRWALI, TQ. BHOOM, DIST. OSMANABAD, PINCODE-413526 MAHARASHTRA for conducting B.Ed. programme of two years duration for one unit (50 students) is restored and is permitted to continue.
